Looking Back At 2018

The year 2018 has been a year of change, challenges and success for the Lancaster Soil and Water Conservation District. As you read through our newsletter you will see that our staff has been busy working to achieve the mission and focus of the Lancaster Conservation District, "To enhance awareness of natural resources by educating school children, citizens, and community leaders about conservation and environmental issues in Lancaster County."

Some of the highlights of 2018 are:

- The success of our Education Program in our schools, poster contests and conservation-related science fair projects.
- The technical assistance offered to our county landowners by our staff.
- The Cane Creek and Little Lynches Watershed Boards and staff have done an excellent job of maintaining the five PL-566 watershed lakes in Lancaster County. During the 2018 historical rainfall events and hurricanes, there were no failures or problems on any of the five sites in Lancaster County.
- The Lancaster Soil and Water Conservation District currently offers three scholarships to Lancaster County students pursuing a career in a natural resources-related field. They are the Glenn Alexander Memorial Scholarship, the Bill Ardrey Forestry Scholarship and the USC-L Lancaster County Soil and Water Conservation District Scholarship. The winner of our 2014 Glenn Alexander Memorial Scholarship, Anna Scott, placed first in the 3rd International Soil Judging contest held in Seropedica, Rio de Janerio, Brazil on August 8-11, 2018. Congratulations Anna!

We as a district have experienced changes with our board and staff this past year. Mr. William (Bill) Ardrey, a long-time Conservation District Commissioner has retired as a commissioner and became a Commissioner Emeritus. Mr. Ardrey continues to assist the board and we are thankful to him for his service.

Mr. Troy Helms was elected as a Commissioner in the November 2018 general election and began serving in February 2019. Mr. Helms is a seasoned agriculture teacher at Buford High School and brings a vast amount of agricultural science knowledge and education experience to our board.

Beginning in June of 2018, the Lancaster Soil and Water Conservation District began sharing a NRCS District Conservationist and NRCS Soil Conservationist with Chesterfield County. Tamarra Roseburgh is the new District Conservationist, and William Walker is the new Soil Conservationist for Lancaster and Chesterfield Counties. 

Cane Creek and Little Lynches Watershed Board Report

This year we had two hurricanes that passed through our area this Fall. We have implemented a system to notify people downstream of an emergency situation at our sites. The wet weather has delayed some of our current projects.



- ⇒Annual inspection on all five dams and spillways
- ⇒Fall/Spring Mowing and partnering with the Lancaster County Water and Sewer District, a sponsor, to mow Bear Creek
- ⇒Directors and staff assisted the public as needed on watershed questions

Weather Delayed Projects:

- ⇒Repairing the Plunge Basin at the Ghent Reservoir
- ⇒Repairing the toe of the dam at Little Lynches
- ⇒Two other projects are waiting on permits from SCDHEC to begin work.



USDA-NRCS Annual Report By Tamarra Roseburgh

The USDA-NRCS offers voluntary conservation programs that provide financial and technical assistance to eligible farmers, ranchers and forest landowners to plan and implement conservation practices to address identified resource concerns through conservation planning. During the conservation planning phase, NRCS will meet with the producer to discuss their goals and objectives and identify resource concerns to be addressed. To get started, visit your local USDA Service Center or visit the website at: www.nrcs.usda.gov/getstarted for more information. Applicants must establish farm records with the Farm Service Agency (FSA) and complete all required eligibility documents for USDA assistance. Eligible land includes: cropland, rangeland, pastureland, non-industrial pri-



vate forestland and other farm or ranch lands. Last year, the Lancaster Service Center wrote plans to improve grazing lands, soil and plant health, air quality, water quality, as well as re-forestation longleaf pine habitat. Our goal for 2019-2020 is to get more conservation on the ground!

Some common practices include, but not limited to: High Tunnel System, Comprehensive Nutrient Management Plan, Tree/Shrub Establishment, Tree/Shrub Site Preparation, Prescribed Grazing, Livestock Watering Systems, Forage and Biomass, and Nutrient Management.




